Now into its 10th year, the focus of Programa Escolhas is on marginalized youth and the program has ongoing initiatives across Portugal, including its urban and rural areas. Dr. Fernado Nunes (INYI member, featured in this issue of the INYI Newsletter) and I had the privilege of visiting one of its initiatives on the outskirts of Lisbon. Its aim, amongst others, was the enhancement of early childhood development through provision of education and health opportunities in a socio-economically disadvantaged neighbourhood. Notable among the features of the initiative was the hiring of staff from the locality, development of a permanent site for access to technology for youth, and a mobile daycare unit providing nutrition to young children and teaching them group play skills. DR. DEBORAH DAVIDSON



Deborah Davidson, Ph.D., is an Assistant Professor in Sociology at York University in Toronto. Her work is focused in the areas of health, motherhood, gender, and diversity. Key projects include perinatal loss and bereavement, hospital protocols and griefwork (a term she coined and developed), familial, professional, and online support for pregnant women with chronic conditions, the use of tattoos for memorialization, and critical pedagogy and diversity in the feminist classroom. Methodologically, Dr. Davidson has expertise in qualitative methods and methodologies, and is particularly adept in participatory methods, auto/biographical approaches, and researching sensitive topics with vulnerable populations. She has published a number of book chapters and articles in a variety of sociological and feminist journals including *Women's Studies International Forum, Sociological Research Online, Feminist Teacher* and the *Journal for the Association of Research on Mothering*. Her community volunteer work is with Bereaved Families of Ontario, where she has served on the Provincial Board, is Chair of the Professional Advisory Committee for Halton-Peel, and participates as peer facilitator and as a facilitation trainer.



DR FERNANDO NUNES



Dr. Fernando Nunes is an Assistant Professor in the Department of Child and Youth Study, Mount Saint Vincent University, Halifax, Nova Scotia. He holds a Ph.D. in the area of Education and Community Development, and a M.Ed. in Applied Psychology, from the Multicultural Focus of OISE/ UT, (the Ontario Institute of Studies in Education of the University of Toronto). Dr. Nunes has conducted research on at-risk immigrant youth, the academic underachievement of Portuguese-Canadian children, Portuguese-Canadian immigrant women, the Lusophone Diaspora and Canada's Partnership Model of immigrant settlement and inclusion. He coordinated the first national study on the Portuguese in Canada: Portuguese-Canadians: From Sea to Sea, wrote the first monograph on the adaptation of the Portuguese in Canada: Problems and Adjustments of the Portuguese Immigrant Family in Canada, in the mid 1980's and one of the first academic articles on Portuguese Immigrant women. He has taught at OISE/UT, Brock, York and Ryerson Universities in the areas of Critical Pedagogy, cross-cultural communication, ethnoracial diversity and the family. He is affiliated through both research activities and previous employment with CERIS-Toronto (The Joint Centre of Excellence for Research on Immigration and Settlement) and its sister organization in the Maritimes, The Atlantic Metropolis Centre. Dr. Nunes has also acquired over 30 years of experience as a volunteer and consultant within the fields of education and social services. He has served as a Board member of community organizations such as the Portuguese-Canadian National Congress, the Portuguese Interagency Network, Canadian National Institute for the Blind-Toronto and the Toronto Community Care Access Centre. In the early 1980s, he also co-founded the first student-led Luso-Canadian student association, the York University Portuquese Association.

His current research activities focus on minority academic underachievement, the civic and political participation of Portuguese-Canadian youth and evaluating the effectiveness of Canada's model of immigration settlement services. His most recent project, funded by the *Social Sciences and Humanities Research Council*, is examining the barriers and support mechanisms to the education of Luso-Canadian youth, in five cities.

1. Welcome to four new INYI members, Dr. Deborah Davidson, Dr. Nasim Haque, Sara Podio-Guidugli and Dr. Eckart Müller-Bachmann.

Dr. Nasim Haque is Director of Community Health at the Wellesley Institute, an independent non-profit research and policy institute based in Toronto. She is currently leading Wellesley Institute's signature project, St. James Town Initiative and is also responsible for immigrant health research projects of the organization. Dr. Haque holds a joint appointment as Assistant professor at the Lawrence Bloomberg School of Nursing, University of Toronto. She is a physician and holds a doctoral degree in social epidemiology from Johns Hopkins School of Public Health.

Ms. Podio-Guidugli holds a Masters degree in Psychology. Her research interests range from cross-cultural research to social psychology as well as personal values.

Dr. Eckart Müller-Bachmann (M.A., Dr. phil.), born 1966, is a sociologist with a background in theoretical sociology, youth sociology and migration issues. He has accomplished research and work experiences in the fields of youth sociology and migration sociology. After working as researcher at the Polytechnic of Dortmund and the University of Chemnitz he worked for a company and the biggest umbrella organisation for Turkish migrants in Germany called the "Türkische Gemeinde in Deutschland". His main objectives there were research and practical orientated projects. The aim of these projects was the integration of young persons with a background in migration and giving them support to find access to vocational training.

Since 2006 he is employed as a researcher and project manager in the social research unit at the CJD (Christliches Jugenddorfwerk Deutschland e.V.) in Eutin and Hamburg. This unit is working mainly on studies within the integration/migration context and on issues of youth delinquency. He worked in research projects – to name a few - on the social capital of migrant communities, on the migration pathes of families, on naturalisation procedures in Europe and processes of intercultural opening in institutions of host societies. Furthermore he worked or on the mediation practises and the involvement of families of delinquent youth. Recently he has accomplished a project on diversity-strategies for small cities and supported these in their launch of a local development process that views diversity in society as a mainstream task of local authority planning. The central focus was the linking of diversity approaches with the economic, social, cultural and ecological development perspectives of the communities. This project has just won the German Diversity Award 2011 (see www.diversity-preis.de).
