She developed the Family Dynamic Environment Scale, which is being used in South Korea as a culturally sensitive instrument. She is also involved in a number of NGO activities for social integration of female migrants entering Korea through international marriages. She has been featured in Marquis's Who's Who in the World of the Year 2007, 2008, and received the Health Professional Award from the International Biographical Center in England. She was also featured in the Great Minds of the 21st Century of the Year 2008 by the American Biographical Institute.
